1. This form must be returned within 28 days of the adoption of the Code of Conduct or within 28 days of your election or appointment to office. You must register your Disclosable Pecuniary Interests in the Register maintained under Sections 30(3) and 235(2) of the Localism Act 2011 and provide written notification of details to the Authority's Monitoring Officer.
2. You must within 28 days of becoming aware of any change to the interests specified above provide written notification to the Monitoring Officer of that change.

3. Under the Authority's Code of Conduct, where Members are offered gifts and hospitality and their value is £50 or over for a single gift/hospitality or £100 or over for all gifts/hospitality from a single source in any year, they are required within 28 days of receiving the offer to register this on the Member Gifts and Hospitality Form maintained by Democratic Services – detailing the date, source and value of the gift/hospitality and whether or not such was accepted. Any such registrations will be published on the Authority's website.
