

ROLE AND PURPOSE OF THE INNOVATION ADVISORY PANEL

Influence and Insight

- Work with the Authority, the Mayor and partners across the “triple helix” of public, private and academic/research sectors to provide strategic leadership for the Greater Lincolnshire innovation agenda
- Support the Authority in delivering its Innovation Strategy by shaping the innovation narrative and offer to industry, government and investors
- Provide recommendations to the Authority on the annual innovation budget and the design of the delivery programme
- Provide recommendations on the use of innovation grant funding by identifying, selecting and prioritising projects
- Act as a convening forum for local innovation ecosystem stakeholders, building connections between sectors and institutions
- Build external relationships with other innovation ecosystems and explore collaboration opportunities



Delivery and Oversight

- Oversee the delivery of the innovation programme and project portfolio and make recommendations to project leads as required
- Support the Authority in developing and agreeing an Innovation Action Plan with Innovate UK
- Review the portfolio of innovation-related business advisory, financial and accelerator support services available to local businesses
- Work with partners to identify where capital investments are required to support improvements in the levels of Research and Development across Greater Lincolnshire
- Advise on the development of a programme of activities and events designed to support businesses to engage with, and improve levels of, innovation
- Support the development of place-based propositions which enhance flagship innovation zones
- Explore and support schemes which increase the level of spinouts and commercialisation activity leading on from initial research collaboration opportunities

ABOUT THE ROLE

OF THE INNOVATION ADVISORY PANEL

The panel will act as an expert advisory group to the GLCCA. It will meet quarterly, with the first meeting scheduled for June 2026.

Membership of the panel will represent the public sector, private sector and academic/research organisations.

We are seeking six private sector members, including a Chair, for a three- year term.

Once complete, there will be 14 panel members in total, including a Chair:

- Four panel members appointed from medium and large private sector businesses, one of whom will be Chair
- Two panel members appointed from start-up and/or scale-up private sector businesses;
- Four panel members appointed from academic/research organisations
- Two panel members appointed from the GLCCA
- One panel member representing the British Business Bank
- One panel member representing Innovate UK



WHO WE ARE LOOKING FOR

We are seeking to appoint six business leaders to our Innovation Panel, representing businesses of different types and sizes from across Greater Lincolnshire.

Private Sector Representation – medium and large businesses

(Four representatives including a Chair)

Senior business leaders with a local, national and/or international profile, representing a business which is resident, operating or has significant interests within Greater Lincolnshire. We are interested in business leaders with either:

- A strong track record in R&D and innovation; or
- Interest and experience in financing innovation projects and/or investing in innovative businesses and technologies

Private Sector Representation – start-ups and scaling (Two representatives).

Founders or leaders of businesses resident or operating within Greater Lincolnshire that have arisen from commercialisation of new research and are at start up or scale up stage.

Commitment

As a panel member, we will ask you to:

- attend quarterly face-to-face Panel meetings; we anticipate these will be two hours per meeting
- travel to the meetings held in different venues across Greater Lincolnshire
- read papers and prepare for meetings, anticipated to be 0.25 day per month or equivalent
- maintain your local currency as an expert in your sector


